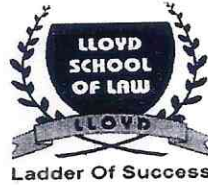
NOTIFICATION

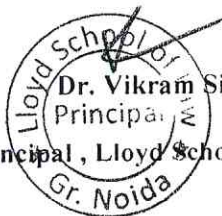


Terms of reference

1. The Cultural Committee shall ordinarily continue for the subsequent academic years and shall not require reconstitution unless considered necessary by the competent authority.
2. The composition of the Committee, including the Cultural Committee Head and Faculty Coordinators of the constituent Cultural Cells/Societies, shall ordinarily remain unchanged. However, Faculty Coordinators may be changed or replaced as and when required by the competent authority.
3. The Committee shall meet once during each academic year to review, discuss and coordinate matters relating to cultural activities, events, competitions, performances, student participation and representation of the College.
4. All cultural activities and programmes shall be conducted with the prior approval of the competent authority and in accordance with the institutional rules and procedures.
5. The Committee shall maintain appropriate records of meetings, cultural activities, student participation, competitions and achievements for institutional documentation and reporting purposes.

Functions of Cultural Committee

1. Planning, coordination and supervision of cultural activities.
2. Coordination of cultural events, competitions, performances and workshops.
3. Facilitation of student participation and representation in approved cultural events.
4. Coordination with Faculty Coordinators of the constituent Cultural Cells/Societies.
5. Ensuring proper supervision, discipline and documentation of cultural activities.
6. Promotion of creativity, artistic expression, teamwork and student development.
